III. KING MIDAS SHORT FILM COMPETITION TERMS AND CONDITIONS OF PARTICIPATION

- 1-Only the films that produced in 2012-2013 can participate in the competition.
- 2- Only in the category of documentary, experimental, fictional and animation films can participate in the competition.
- 3- Duration is limited as 30 minutes for documentaries and 20 minutes for the other kinds.
- 4- One participant can attend the competition with more than a film and various kinds.
- 5- The films attended a festival or competition before, can participate in that competition.
- 6- The participant should send to the address represented; 2 DVD copies including English subtitles, 2 copies in Avi format and a DVD which consist of film's documents (photos from the set, film frames, copyright page, subtitle text, notes, etc..) with the attendance form taken from www.kralmidas.com by signing it. The deadline is 30 April 2013.
- 7- In order to assess and follow the films in international areas, they should be sent with their English subtitles.
- 8-The films sent are to be archieved in King Midas Short Film Festival archieve. If it requires, they will be assessed in King Midas Short Film Festival. If the film is shown off, the participant represented in the form will be informed by e-mailing. The films sent to King Midas Short Film Festival will never be given away to the others in consider of pecuniary advantages.
- 9- After the end of application date for the year 2013, King Midas short film festival could use the names and if it requires some scenes of the film -not the whole- on media tools like the Internet, social media, radios and TVs as on an introductory basis and promotion.
- 10- In the festival only the films that approved by the first jury will be shown and some films choosen by the 'King Midas Main Jury' will be awarded in various categories. The decision of first selection committee and the main jury is accurate.
- 11- The films sent to the festival by giving participant name is accepted as agreeing the conditions of the festival by the participant
- 12-Each participant attend the competition regarded as accepted the conditions. The festival committee has the power to take decisions for the rest. You can download the attendance form that is to be accepted by the participants who want to attend the festival from www.kralmidas.com
